**All Vendors:** On-Sites and Technicians with **current** gaming licenses who change companies or the company is purchased and a new license is required, will be charged a fee of \$25.00 per license.


**Notice Regarding Late Fees:**

Renewal applications for **ALL** license types *must* be submitted **no later than 60 days** prior to expiration. Additional fees will apply to any application received late. Due to high application volumes, the ONGC cannot guarantee that background investigations for late application renewals will be completed prior to expiration.

**Employees submitting late renewal applications are NOT subject to receive a Day-Pass. There will be no exceptions.**
