4. Superintendent Report – Adam Trumbly

Superintendent Trumbly states the superintendent report is as follows: Total oil produced 323,251.01, royalties paid \$3,469,137.06, total gas produced 307,112 MCF, royalties paid \$100,123.26, total gas liquids 571,698 gallons, royalties paid \$67,958.71, total tank bottom 64.12, royalties paid \$147.89, water usage royalty paid \$650.00, and waste disposal royalty paid \$3,417.86. Rentals/Bonus - Oil and Gas Rentals Paid \$7,360.00, Oil and Gas Bonus Paid \$0, Rental \$0, Saltwater Easement Rental \$1,800.00, Late Payment Charge \$1,178.40. Aggregates - APAC produced 24,191.42 tons and paid \$30,481.19 in royalty (October). Candy Creek produced 9,013.21 tons and paid \$10,094.80 in royalty (September). Burbank Materials produced 7,597.44 tons and paid \$9,800.69 in royalty (September). Rocky Banks produced 318 cubic yards and paid \$165.00 in royalty (October). Wilson Ranch produced 0 tons and paid \$3.75 in annual rental. Schmidt Brothers produced 440 cubic yards and paid \$333.00 in royalty (October) and produced 320 cubic yards and paid \$240.00 in royalty (September). Producing wells -16,445, oil wells -11,932, oil and gas wells -114, gas wells -1,342, TA'd -492, Injection Wells – 1,254, Injection w/easement – 8, CO₂ Injection – 72, Water/Gas Injection – 51, SWD w/easement – 130, SWD w/o easement – 941, Water Supply Well – 102, Water Supply Well w/easement - 2. Permits issued - 5 workover, 4 plugging, 0 emergency plugging, 0 emergency workover and 0 drilling permits. There are 0 new drilling completions to report. Councilman Revard asks if Superintendent Trumbly has heard any more on Nucera's plans or progress. Superintendent Trumbly says that he

 - c. Letter to Superintendent Information Request Chairman Red Eagle OMC Geologist Bill Lynn reviews a letter he prepared asking the BIA for well information from 2016 to present. Councilman Revard states that the lack of access to well records as well as regulations has negatively affected drilling. Councilman Shackelford states that the OMC stated certain things that they wanted to accomplish when they took office and the access to well records was very important to oil producers. Councilman Revard reiterates that we are not competitive with surrounding counties and that this would help. Congresswoman Whitehorn asks if the OMC would have to pay to get the copies and Superintendent Trumbly states that he will accommodate what he can.
